You should be receiving your ballot in the mail for the annual election for the Board of Directors and Neighborhood Representatives. There are two (2) Board of Director positions available for terms beginning in January 2016. Directors serve a three year term.

This year's slate of Board of Director candidates include:

Mary Favre, Alta (Bitsy) Hancock and Sean Hartig. Information on the Board of Director candidates was in the October newsletter but if you missed it your can visit the website at <u>www.firstcolony.org</u> under "Elections" for information and pictures on the candidates.

Each separate neighborhood may have up to three (3) elected Neighborhood Representatives. They are elected annually by the property owners in their neighborhoods and serve a one-year term.

The entire voting tabulation will be done by an election services company, Election Trust. As a member you will have the opportunity to vote for two (2) of the three (3) Board candidates on the ballot.

You have two options:

1). Fill out your ballot by hand and mail it to Election Trust in the pre-paid, pre-addressed envelope or

2). Fill out your ballot via computer, following the instructions enclosed with your ballot. Election Trust has a toll-free telephone and an email voter "help desk" support system if you need assistance.

Please note the appropriate deadline: all ballots, whether mailed or on-line, must be received by Election Trust by 5:00 pm on November 19, 2015. If you do not receive your FCCA election ballot in the mail please contact Election Trust at <u>help@electiontrust.com</u> or call the help desk at 1-866-429-9481.

# Kayak Fun on Brooks Lake



There is still time to have fun on Brooks Lake by checking-out a kayak at the Oyster Creek

Boathouse. The boathouse is open Saturdays and Sundays through October 25th. Hours of operations are:

- Saturdays: 10 am 7 pm
- Sundays: 1 pm 6 pm

You must be 21 years of age or older to check-out a kayak. Rowers under 21 must be accompanied by an adult. There is no cost to check-out a kayak for First Colony Community Association (FCCA) members. You must have a current FCCA pool tag as proof of residency. Pool tags are available to members at the FCCA office located at 4350 Austin Parkway, Sugar Land. Office hours are Monday - Friday from 8 am - 5 pm

You will need to show proof of residency to receive a pool tag by providing your driver's license or a current utility bill. At kayak checkout you will be required to leave a driver's license and sign a liability form. Non-residents may check-out a kayak by purchasing a pass at the FCCA office. One use pass is \$10.00 per person. Reservations are not accepted, as kayaks are checked out on a first come, first served basis. Kayaking experience is not necessary (though it is a good idea to have a general knowledge of rowing). In addition, life preservers are provided to all participants. Don't forget to bring along sun block and drinking water.

#### **New Tree Planting Update**

Trees are an important and treasured part of First Colony; however, they have been over-planted and the selective removal of certain trees will result in better health, appearance, and longevity of the remaining trees.

With the removal of the Bradford Pear trees earlier this year, it was determined that more than one species of tree should be considered. Diversity of trees, for the purpose of disease resistance as well as aesthetics, is needed in First Colony. Each landscape reserve area

will be considered separately when determining the replacement tree type. Trees species were selected based on hardiness in our area and seasonal interest. Some trees that we will be using are Mexican White Oak, Drummond Red Maple, Mexican Plum, Sierra Red Oak, Redbud, Chinese Pistache, Creole Queen Elm Tree, Highbeam Overcup Oak and Crapemyrtles.

Planting should commence again this month in areas where there is no construction.

# Fort Bend Votes Anywhere!



This November 3rd, Fort Bend County will be changing the way we vote on Election Day.

Voters will now be able to cast a ballot at any of 78 Vote Centers. In the past they could only vote at one assigned polling location. About one third of the Election Day polling places are new, so voters are encouraged to visit the Fort Bend Election website, www.fortbendvotes.org in order to find a convenient voting location.

Voters will still be able to cast a ballot during the Early Voting period of October 19-17 at any of 17 sites.

# **Political Signs**

Below is a list of the guideline regulations regarding time and placement of political signs. You may also find the information in our new Property Improvement Procedures & Guideline Manual available on our website www.firstcolony.org under the Compliance tab.

- Only one sign per candidate or ballot item may be placed in the homeowner's yard. Signs cannot be placed on the right of way or common area property.
- A sign may be installed a maximum of four (4) feet above ground level.
- The sign may be no greater than six (6) square feet.
- Sign may be installed 90 days prior to the election date.
- Signs are to be removed within 10 days following the election.

#### Turf & Tree - Site 2 - Sweetwater Blvd.

During the week of September 28, 2015, FCCA started work on its second tree removal and turf restoration project along Sweetwater Blvd., adjacent to the Crescents on the Green neighborhood. After the success of the first tree and turf project last year along Edgewater Blvd, FCCA received several requests from Crescents on the Green residents to help resolve tree and turf issues in their area. Because of overplanting, the neighborhood was experiencing some serious tree root intrusion issues along with the inability to grow grass because of the tree canopy.

During their August 27, 2015 meeting the FCCA Board of Directors reviewed the proposed plan and indicated their support to move forward with the project and directed staff to get competitive bids, and develop a project schedule. The Board formally approved the tree and turf project during their September 17, 2015 meeting. The 2015 FCCA budget included funding for this type of project and no additional allocation was necessary to cover the actual project costs. Work began during the week of September 28, 2015 and is scheduled to be completed in early November, barring any weather delays.

The project involved the removal of 40 trees along Sweetwater Blvd, repair of the existing irrigation system and sodding the area. Also, the project calls for the contractor to remove the trees and split them into firewood. Once the fire wood is split it will be staged in the Austin Park Pool parking lot for FCCA members to pick up as they wish at no charge. FCCA will announce on our website when the fire wood is available. If you have any questions about this project please contact David Pella, FCCA Landscape and Operations Manager, at 281-634-9566.



# **Residential Compliance Inspection Schedule**

Deed restriction enforcement helps to maintain property value and to improve the overall appearance of the community. Note: Schedules vary due to weather, holidays or vacations.

An application must be submitted for approval prior to the commencement of any type of exterior change or construction on the property.



# Indo-Americans Celebrate Diwali

The name Diwali signifies 'rows of lighted lamps'. Diwali is a five-day festival, beginning on the 15th day of the Hindu calendar month of Kartika (Ashwin). By the Gregorian calendar, Diwali falls in October or

November.

This year Indo-Americans will be celebrating Diwali starting on Wednesday, November 11th and will continue for 5 days until Sunday, November 15th.

The universal theme of celebration is happiness and hope. The festival is celebrated for five continuous days with family gatherings, glittering clay lamps, festive fireworks, strings of electric lights, flowers, sharing of sweets, and worship.

Diwali holiday lighting on the exterior of the home is allowed within the Association. It is limited to the period of Diwali. The FCCA guidelines for Holiday decorating states that decorations may be installed fourteen (14) days prior to the holiday and must be removed within five (5) days after the holiday is over.
